Mama Sharon also states that she treated Sharon like just another child, assigning her house chores according to her ability, and enabling her to even do more through enhancing her reach, for instance, cooking. She says that she would enhance the cooking facilities to enable her to cook.

Further, Mama Sharon has helped coordinate the women in her local area who have children living with disabilities.
